Subject: - Revision of Shearing Charges

O R D E R


As recommended in the meeting of Farm/Field Officers held on 11-10-2018 at Directorate of Sheep Husbandry Kashmir, the Shearing Charges are hereby revised w.e.f.01-04-2019.

The review of the shearing charges has been done by the committee after in-depth study/analysis of major price determining factors viz:

- **Cost of spares/accessories**
- **Cost of POL items/electricity tariff**
- **Price inflation in essential commodities**
- **Back up facilities/logistic support rendered by the Department to the trained youth**

Accordingly, it is ordered that:

- i) Shearing charges are revised from existing Rs.15.00 per animal to Rs.20.00 per animal plus running/ maintenance charges which shall be borne by the breeder as per norms (Petrol @ 20 sheep per litre, M.Oil @100 sheep per litre and Grease @ 1000 sheep per Kg.) which should not exceed Rs.10.00 per sheep shorn in case of Petrol plant and Rs. 5.00 per sheep shorn in case of electric plant respectively.
- ii) Minor repairing/overhauling of machines shall also be met out from the running maintenance charges of Rs.10.00 and Rs.5.00 respectively by the concerned shearer.
- iii) 40% of the amount earned by private shearer per sheep as shearing charges i.e Rs:8.00 shall be deposited by him with the Department in lieu of cost of accessories (combs/cutters etc.) issued to him.
- iv) The accessories shall be issued to the private shearer only on the recommendations of the respective District Officer under proper receipt.
- v) 50% of the cost of spares, if any, to be fitted in the machine during mandatory periodical check-ups of the equipments at Departmental Workshop shall be borne by the private shearer.
