## ORDER

The department has an availability of more than 250 Sheep & Goats for sale and; contemplates to sell these animals at a centralized place viz. Zakura Srinagar. The sale will commence on 8th August 2019 at 10:00 hrs

The committee will:-

Camp at Feeding Centre Zakura w.e.f 5<sup>th</sup> to 10<sup>th</sup> August 2019 or till culmination of sale whichever is earlier (The leftover animals, if any, be shifted to SBF Dachigam – Khimber Station.



- > Properly verify the animals at the time of receipt and record body weights before sale.
- Remain in close liaison with this directorate.
- Maintain the farm/organization wise records (sale statements etc) and remit the sale proceeds into the Govt. treasury through office of the Deputy Director, SBF Dachigam on daily basis.
- By or before 20-08-2019 handover copies of the duly signed documents, statements, chalans etc. to the concerned field/farm officer who will reflect the same in statements for the month of August 2019 <u>as sale at Srinagar</u>.

- All DSHOs and Farm Officers will ensure that the livestock (already sanctioned for sale) is pooled at above mentioned sale point <u>between 6<sup>th</sup> to 9<sup>th</sup> August 2019</u> positively and will arrange sufficient number of departmental personnel for escorting the stock and handing-over the same to designated committee. Furthermore DSHOs will keep the said stock available at road side at not more than 3 spots in their respective areas of jurisdiction for lifting to Srinagar through departmental vehicles.
- Store Officer SHD Kashmir will arrange/ensure transportation of animals from farms/field to designated place.



- > DSHO, Srinagar will make fodder and accommodation available for livestock during the sale period and will also provide all logistic support to committee and ancillary staff for smooth accomplishment of the activity.
- The Joint Director Farms; Joint Director Extension; Deputy Director Research, DIL, Nowshera; District Sheep Husbandry Officer Srinagar/Budgam & Ganderbal; Deputy Director SBF Daksum and Dachigam will releve the concerned officers/officials at appropraite time for enabling their reporting at FC Zakura on 05-08-2019 (FN).
