
Pursuant to the selection list submitted by J&K Service Selection Board, Jammu under letter No: SSB/Secy/Sel/2016/21145-52 Dated: 19/12/2016 endorsed by Administrative Department, Animal/Sheep Husbandry Department, J&K vide reference (i) quoted above, sanction is hereby accorded to the temporary appointment of Masood Ahmad Bhat S/o: Habibullah Bhat R/o: Daulatabad, Srinagar as Librarian (Divisional cadre, Kashmir) under Open Merit on probation basis for a period of two years against the available post in the pay scale of Rs. 9300 – 34800 + G.P. 4200/- admissible under rules.

The appointment shall be subject to the following conditions:

01. The appointee shall have to give an undertaking in the shape of an affidavit to the effect that in case of any adverse report against him with regard to prescribed qualification/DOB, character and antecedents received from police (CID), J&K; necessary action under rules shall be taken against him and he shall be liable for termination.

02. The new appointee is directed to join at his place of posting within a period of 15 days positively from the issuance of this appointment order, failing which the Department is at liberty to cancel his appointment orders under rules.

However, the salary of newly appointee shall be drawn and disbursed only after checking/verifying/authenticating his all documents/qualification/category certificates and other testimonials and antecedents required under rules.
