Tenders without tender fee shall be rejected.
2. The Tender should be accompanied with Call Deposit Receipt of Rs.2,000/- of any Nationalized bank pledged to the Accounts Officer Sheep Husbandry Kashmir.
3. Rates quoted/approved for each item shall remain valid for one year.
4. The Tender should reach to the office of Director Sheep Husbandry Kashmir by or before 28<sup>th</sup> February 2017 up-to 02:30 pm by hand or registered/speed post. The tenders received after the due date and time shall not be accepted. In case the last date for receipt of Tenders happens to be holiday, the same shall be received on the next working day. The tenders shall be opened by the committee on the same day or any other date convenient to the Committee in presence of tenderer's who wish to be present. The postal delay shall not be the responsibility of the department.
5. The sample should be deposited before the last date for receipt of tenders.
