

ORDER NO:- 338 SHD OF 2016
DATED :- 01 - 02 - 2016

1. Whereas, Mr. Tawseef Sultan ASM of District Organization Anantnag was transferred to Sheep Breeding Farm Daksum vide this office Order No:-94 –SHD of 2013, dated:- 11.06.2013 and relieved by the District Sheep Husbandry Officer, Anantnag on 14-01-2015 for further duties.
2. Whereas, the incumbent joined at the Farm on 20.01.2015 as intimated by the Dy. Director, Sheep Breeding Farm Daksum vide his No:-SBFD/Estt/145-48, dated 08.05.2015.
3. Whereas, he left the Farm just after his joining without submission of any kind of leave or obtaining of proper permission from the concerned authority as intimated by the concerned Drawing and Disbursing Officer vide his No:- SBFD/Estt/2014-15/935, dated:-09.03.2015.
4. Whereas, the Deputy Director, SBF, Daksum directed him to attend the duties immediately but he failed to do so vide his reference No:-SBFD/Estt/2015-16/1054-57, dated:-01.10.2015.
5. Whereas, he neither submitted any reply to the explanations served to him nor resumed his legitimate duties vide reference No.SBFD/Estt/2014-15/939, dated:-11.03.2015.
6. Whereas, the official namely Tawseef Sultan again joined the duties on 25.07.2015 after prolonged absence of five months and the period of absence was treated as “Dies non” in accordance with SRO 514 dated:-22.11.1999 vide this office letter No:-DSHK/Gen-14/Inf/57-97-98 dated:-31.08.1915.
7. Whereas, he again left the Farm on 29.08.2015 without any proper permission from the concerned officer vide Dy. Director, Sheep Breeding Farm, Daksum’s letter No:-SBFD./ERstt/2015-16/1054-57, dated:-01.10.2015.
8. Whereas whereabouts of the incumbent were not known and subsequently the Assistant Stockmen was placed under suspension vide Dy. Director, Sheep Breeding Farm, Daksum’s letter No: - SBFD/Estt/1183-86 dated: - 21-10-2015.
9. Whereas, the incumbent was served final mercy chance to attend his legitimate duty and notification was published in daily News Paper “English” and “Urdu” through Joint Director, Information Department vide this office No: - DSHK/Gen-14/Inf/3952-55 dated: - 21-07-2015, but he did not pay any attention towards the matter.

10. Whereas, it had been felt from the date of his joining in the Department that he is not interested to serve in the department.

In view of above facts, and as recommended by the Deputy Director, Sheep Breeding Farm Daksum vide his reference No: - SBFD/Estt/2014-15/1668-70 dated: -16-12-2015, it is hereby ordered that the services of Mr. Tawseef Sultan Bhat S/o Mr. Mohd Sultan Bhat R/o Khiram, Bijbehara. (Assistant Stockman) of Sheep Breeding Farm Daksum are hereby terminated w.e.f 20-01-2015.
