

The appointment shall be subject to the following conditions: -

01. Each appointee shall have to give an undertaking in the shape of an affidavit to the effect that in case of any adverse report against him/her with regard to prescribed qualification/DOB, character and antecedents received from police (CID), J&K; necessary action under rules shall be taken against him/her and shall be liable for termination.
02. All the new appointees are directed to join at their place of posting within a period of 15 days positively from the issuance of this appointment order, failing which the Department is at liberty to cancel their appointment orders under rules.
03. The probation bar of the appointees shall not be cleared, even if their performance is reported satisfactory by their controlling officers, till they qualify the Departmental Stock Assistant Training Course, which is the prime requirement of the post and precedence of the Department.
04. The appointees shall have to perform their duty turn by turn compulsorily at Sheep Breeding Farms.



The concerned Drawing and Disbursing Officers are directed to allow the joining of newly recruited candidates only after production of following requisite certificates: -

1. Academic qualification certificate/marks certificate.
2. Date of Birth Certificate.
3. Permanent Residential Certificate.
4. Relevant category certificate (in case of candidates belonging to reserved category).
5. Medical fitness certificate.
6. No loan certificate from DIC/employment exchange.
7. Character certificate.

However, the salary of newly appointees shall be drawn and disbursed only after checking/verifying/authenticating his/her all documents/qualification/category certificates and other testimonials and antecedents required under rules.
