Sanction is hereby accorded to the constitution of committee for formulating standard operating procedures in farms and field organizations. The committee shall be referred as Joint Technical Committee.

The terms of reference for the said committee are as under:-

- Assessment of all farms vis-à-vis infrastructure, grazing facilities (contiguous/subalpine/alpine pastures), fodder land, manpower and previous performance (especially in terms of ram output and fodder production for last five years).
- Workout the minimum and maximum livestock strength to be maintained in each farm particularly in reference to farm fodder production to encourage self sufficiency & sustainability, set targets for number of rams to be produced & distributed each year and fodder to be produced per year.
- Workout the targets for field activities (like ram:centre ratio, rationalization of SEC requirement, birth registration, innovations etc) based on current supply and demands in order to explore the via media for easeful delivery of services to farmers.
- Inspection of all works (vis-à-vis status of construction) & existing departmental assets (current status and utility) and submission of feedbacks/reports routinely to directorate in this regard.

The JTC will visit all farms in 1st first instance and furnish its report, covering the ToR No. A & B, within 3 weeks.

Note: The JTC shall receive all logistic and backup support from directorate.
