The nominated candidate shall have to file an affidavit to Principal Training Class duly attested by the 1st Class Magistrate to the effect that:-

1. The candidate nominated for training shall not claim for promotion after completion of successful training to the post of Stock Assistant till post becomes available under departmental quota in the District.
2. The nominated candidate shall have no objection if the authority issues orders for disbanding of the training session in case of emergency like outbreak etc.
3. In case any error is noticed at any stage in the documents produced i.e seniority, initial appointment and academic qualification whatsoever, the responsibility shall lie on the nominated official and his nomination shall be liable for cancellation.

The Principal, Training Class shall allow the candidate to join only after production of the required documents including **Matric with Science Certificate** which is to be forwarded to **BOSE** for its verification. In case any error is noticed in the documents, the candidate shall be recalled back from the said training course without any further notice and shall be penalized.
