Reference:- Representation of Mr.Syed Zulfkar Aziz Andrabi Flock Supervisor for rectifying the error in the Seniority list.

NOTICE

Whereas Mr.Syed Zulfkar Aziz Andrabi Flock Supervisor of DSHO, Budgam presently posted at Joint Director Farms, SHD Kashmir approached this office through a representation and requested that his juniors have been promoted and placed above him in the Seniority List of 04/2020.

Whereas this office requested DSHO, Budgam to furnish the service Bio-data of Stock Assistants of his Organisation who have been promoted as Flock Supervisors after 26-08-2006 vide this office letter No:- DSHK/Estt-75/NG/Sup/II/6229 Dated:- 03-08-2021.

Whereas DSHO, Budgam has submitted the service Bio-date of Stock Assistants who were promoted as Flock Supervisors after 26-08-2006 vide letter No:- DSHOB/Estt-31/2021-22/1493 dated:- 10-08-2021.


Whereas after scrutinizing the list of Stock Assistants who were promoted as Flock Supervisors submitted by the said officer, it has been observed that the date of appointment of Mr. Zulfarkar Aziz Andrabi is 15-06-2006 as Stock Assistant.

Whereas, in the Seniority list issued by this office on 01-04-2020, his Date of appointment is 31-03-2007 and the official was promoted as Flock Supervisor w. e. f 26-08-2011.

Whereas his colleagues whose Date of appointment as Stock Assistant is 26-08-2006 have been promoted as Flock Supervisors w. e. f 26-08-2011, but the said official was placed at S.No 53 in the seniority list below the officials namely Bashir Ahmad Wagay II, Bashir Ahmad Wagay I and Ab.Rashid Wani who are at S.No 50,51,52 respectively in the seniority list issued by this office.

Whereas it appears that Mr.Syed Zulfkar Aziz Andrabi is senior to Bashir Ahmad Wagay II Bashir Ahmad wagay I and Ab. Rashid wani and should have been placed at S.No 50 in the seniority list above the aforementioned officials.

Now therefore, before giving consideration to the plea of the applicant it is hereby notified for information of all concerned that if anybody has any objection for considering the representation of Mr.Syed Zulfkar Aziz Andrabi for placement in the seniority list below Mr.Mohammad Yousef Bani and above Mr.Bashir Ahmiad Wagay I from where he was eligible, the same shall be submitted to this office with documentary evidence within a period of (15) fifteen days from the date of issue of this notifications failing which further necessary action under rules shall follow.
