In compliance to Administrative Department`s references captioned above, sanction is hereby accorded to the temporary appointment of Mr. Mohd. Amin Chopan S/o: Gh. Mohd. Chopan (Ex ASM) R/o: Baghiroop Singh, Khanyar, Srinagar on compassionate grounds under SRO-43 of 1994 as Multi Tasking Staff (MTS) District Cadre, Srinagar in the pay level SL-1 (Rs.14800 - 47100) against an available post.

The appointee shall report to Deputy Director, Sheep Breeding Farm, Khimber within a period of twenty-one (21) days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-


- I. Academic qualification certificate.
- II. Date of Birth Certificate
- III. Domicile certificate
- IV. Health certificate from the concerned Chief Medical Officer of the District.
- V. Dependent certificate issued by the Assistant Commissioner Revenue.
- VI. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- VII. All other relevant documents as are required under SRO - 43/1994.

The appointment of the appointee shall further be subject to the following conditions:-

- a. That he shall give an undertaking in the shape of an Affidavit to the effect that if, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV (MTS) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above is received in his favour.
- c. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO - 400 of 2009 Dated: 24/12/2009.
- d. That if the appointee has taken loan for self-employment from DIC/Employment Department to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of his domicile district, the appointee shall be required to repay the entire loan facility in suitable EMI's to be worked out by the DDO concerned from his salary. The appointee shall also relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. The DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
- e. If the appointee fails to join within a period of twenty one (21) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
