
Above mentioned candidates shall report to concerned officers shown against each within a period of 21 days from the date of issuance of this order. If any candidate fails to join within the stipulated time, he shall forego his right to appointment and same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of following certificates / documents (in original) to be verified subsequently.

1. Academic Qualification certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Health Certificate from Concerned quarters.
5. NOC from Concerned DIC / employment exchange.
6. Category certificate ( in case candidate belonging to reserved category).
7. Valid Driving License.

The appointment of the above candidates shall further be subject to the following conditions that:-

- a. The appointee shall give an undertaking in the shape of an affidavit duly attested by ist class Magistrate to the effect that if, on verification, genuineness of the certificate(s) produced by him are proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- b. The appointee shall be on probation for a period of two years.
- c. The appointment of above candidates shall be governed by the "New Pension Scheme" a per SRO 400 of 2009 dated: 24-12-2009.
- d. The appointment of the above appointees shall be subject to the outcome of writ petition(s) if any, pending before any Honourable court of Law.
- e. The salary of the officials shall not be drawn and disbursed to him unless a satisfactory report in respect of genuineness of qualification/Date of birth/category certificate, if any, is received from the concerned authorities
