Subject: Re-joining of Mr. Mushtaq Ahmad Raina Field Man, Sheep Breeding Farm Daksum & Mr. Younis Ahmad Rather, Field Man, Sheep Breeding Farm, Kewa.

Whereas, Mr. Mushtaq Ahmad Raina & Mr. Younis Ahmad Rather, have been appointed as Field Man vide Government order No. 165-JK(ASH) of 2021 dated 22.10.2021 and adjusted at Sheep Breeding Farm Daksum & Kewa respectively;

Whereas, Deputy Director, Sheep Breeding Farm Daksum vide letter No. SBF/D/Estt/2022-23/839-39 dated 15.07.2022 informed that Mr. Mushtaq Ahmad Raina, Field Man has tendered resignation on 26.04.2022 owing to health issue, besides Assistant Director, SBF Kewa vide letter No. SBFK/Estt/2022-23 dated 08.04.2022 also intimated that Mr. Younis Ahmad Rather, Field Man has tendered his resignation on 01.04.2022 owing to higher studies;

Whereas, on 17.08.2022 & 01.09.2022 both the applicants came up with an application to this Directorate requesting therein that they may be allowed to re-join the duties with the reasons that they were mentally disturbed at the time of submitting their resignations;

Whereas, the matter was taken up with the Administrative Department vide this department's letter dated 26.11.2022 for further instructions;


Whereas, Administrative Department vide letter No. ASHF-HONGAZ/16/2022 dated 30.12.2022 conveyed to settle the cases of both the officials under rules, who have represented for re-joining, if they are on probation, extend their probation period by the period they remained absent from duties with an undertaking regarding the activities of said period and if they have already completed their probation, treat the absent period as leave whatever kind due;

Whereas, the applications dated 17.08.2022 & 01.09.2022 have been examined in the department and in light of the instructions of the Administrative Department, both the officials submitted their Affidavits duly attested by the 1st Class Magistrate to the effect that they have not involved themselves in any subversive / anti national / criminal activities or any other activities from the date of their resignation till date;

Therefore in terms of Article 163 of J&K CSR Volume (1) read with SRO 514 of 1999 dated 22.11.1999 and in view of their applications and affidavits thereof both Mr. Mushtaq Ahmad Raina, Field Man & Mr. Younis Ahmad Rather, Field Man, are allowed to rejoin their services in Sheep Breeding Farm Daksum & Kewa w.e.f. 1st June 2023 subject to the following conditions:-

1. They are allowed to join in the Department as afresh and their seniority shall be determined in terms of Rule 24 of J&K CC&A Rules 1956;
2. The period of absence of Mr. Mushtaq Ahmad Raina, Field Man w.e.f. 26.04.2022 & Mr. Younis Ahmad Rather, w.e.f. 01.04.2022 till date shall be treated as DIES-NON in pursuance to SRO 514 of 1999 dated 22.11.1999. The period shall not count for any service benefits;
3. Their seniority shall be re-fixed at appropriate place, subject to confirmation of their probation period and they shall not make any claim for the same;
4. The probation period of both the officials is also extended for one year beyond the period they were expected to complete the same.
