- 1.3: Clarifications if any will be entertained from 22.04.2024 to 28.04.2024.
- 1.4: The technical bids uploaded on the website will be opened on 14.05.2024 (2:00pm) in the office chamber of Chairman, Divisional Level Purchase Committee, Sheep Husbandry Department JandK, Kashmir (Director Sheep Husbandry Department, Agriculture Complex, LalMandi Srinagar Kashmir. In case, the said date is declared as holiday the bids will be opened on the next working day at the same time.
- 1.5: The above schedule regarding date and time is tentatively fixed, however, the Chairman DLPC reserves the right to change the date and time of activities in case of any exigency through a notice on e-tenderingportal www.jktenders.gov.in and on official website of the Directorate of Sheep Husbandry Kashmir.
- 1.6: Tenders received after due date and time shall not be accepted.
- 1.7: Disclosure of rate/discounts special offers in the technical bid may be understood as mal practice and as such the bid shall be rejected.
- 1.8: All the original documents should be produced at the time of scrutiny, if asked for by the technical evaluation committee.
- 1.9: The DLPC reserves the right to accept or reject any tender or any part of the tender before, during or after the tender without assigning any reason thereof.
- 1.10: No conditional tender will be accepted entertained.

- 1.11: The bidder has to submit a tender fee of Rs1 500/= in form of a demand draft(Hard copy) in favour of Member secretary Accounts Officer Sheep Husbandry Department Kashmir, by the last date of submission of online bid, in an envelope clearly mentioning the e-NIT no.
- 1.12: The tenders without tender fee shall be out rightly rejected. Firms that are eligible for exemption for the payment of tender fee have to submit and upload the scanned document in support of such exemption.
- 1.13 No technical/financial bid shall be accepted in hard copy.
- 1.14 Procurement shall be made in accordance to provision 1.10.6 of Manual for procurement of Goods (June 2022) as such only class I local supplier shall be eligible to participate in the tender. The bidder shall be required to indicate percentage of local content and details of the location (s) at which local value addition is made. The self-certification shall be provided that the item offered meets the local content requirement for class I local supplier. False declaration will be a breach of the code of integrity under rule 175 (1) (i) (h) of GFR for which bidder or its successor shall be debarred for two years along with such other actions as may be permissible under law.
- 1.18 In tender participating micro & small enterprises quoting within price band of L1 + 15% shall also be allowed to supply a portion (up to 25%) by bringing down their price to L1. within 25% a purchase preference of 4% shall be reserved for MSE owned by scheduled caste (SC)/ Schedule tribe (ST) entrepreneurs & 3% is reserved for MSE's owned by women entrepreneur (If they participate in the tender process & match the L1 price). However in the event of failure of such MSE's to participate in tender process or meet tender requirement at L1 price, 4% sub target for procurement remarked for MSE's owned SC/ST entrepreneurs & 3% remarked to women entrepreneur will be met from other MSE's .MSE's would be treated as owned by SC/ST.
- 1.19 In case of MSE's the condition of submission of EMD has been relaxed instead they shall submit a security bid declaration in the form of annexure 1(a). For the exemptions the MSE has to upload the udhyog aadhar registration. The benefits of Public procurement policy applicable to MSE's shall be given to all eligible MSE's irrespective of relevance of product category in light of GOI OM no-Ministry of small and medium enterprises OM no-1(3)/2018-ma part 3 Dt-25.03.2022.
- 1.20:- Retail and wholesale traders registered on Udhyam portal are not eligible for benefit from public procurement policies for MSE's.
- 1.22:- The authorised distributor(having udhyog aadhar registration) participating on behalf of non MSE principal manufacturer shall not be eligible for emd, tender fee relaxation and for any purchase preference as per procurement policy for MSE's.
- 1.21:- The condition of prior turnover and prior experience has been relaxed for start-ups only which are recognised by department of promotion of industry and internal trade and the start up claiming exemption has to upload certificate from DPIIT as clarified by Ministry of micro small scale industries vide letter no-F.18/14/2020-ppd dt-29.6.2020.
- 1.22:- Apart from the above necessary eligible criteria other documents required from the bidder as envisaged in the other conditions of the tender documents are mandatory for being eligible in the present proposal of the tender.
- 1.23:- A bidder shall not have conflict of interest with other bidders. A bidder found to have conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process , if :
- (a) they have controlling partner(s) in common or
- (b) they receive or have received any direct or indirect subsidy/financial stake from any of them or

- (c) they have the same legal representative/agent for purposes of this bid : or
- (d) they have relationship with each other , directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another bidder :or
- (e) bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one bid will result in the disqualification of all bids in which the parties are involved. However , this does not limit the inclusion of the components/sub-assembly/assemblies from one bidding manufacturer in more than one bid.

2. EMD/Performance Security:-

- 2.1:- Bid security/earnest money for an amount of Rs.150600/- One lakh fifty thousand six hundred only in the form of accounts payee demand draft, fixed deposit favouring A.O Sheep Husbandry Kashmir, Lal Mandi, Srinagar J & K initially valid for a period of 6 months to be extended further as per finalization of the contract. The bidder has to upload scanned copy of CDR/FDR/DD with the bid and hard copy shall be submitted by the last date of the submission of bid in an envelope clearly mentioning the e-NIT no. EMD of unsuccessful bidders will be returned to them at an earliest after the award of contract to successful bidder but the department shall not be responsible for any loss or depreciation that may occur as hither-to-fore while in its possession nor be liable to pay any interest thereof. EMD shall be refunded to the successful bidder on receipt of performance security.
- 2.2:-The successful bidder shall have to deposit refundable performance security equal to 5% of the supply value of the purchase order in form of CDR/FDR and additional security equal to 5% of supply order value valid for the period of comprehensive maintenance, in the form of bank guarantee Favouring AO Kashmir. In case of failure to make the said deposit the contract shall be cancelled. The security deposit shall be liable to be forfeited by order generating authority for non/short supply of the ordered item in stipulated time frame from the receipt of order. Partial deposit or previous deposit of the security money for any supply order will not be entertained and new security deposit should be submitted for each supply order. The performance security will also be forfeited in the event of breach of contract or unsatisfactory supplies. 5% of performance Security deposited will be refunded after satisfactory completion of the warranty obligations and 5% additional security shall be released after completion of comprehensive maintenance. 5% performance security is to be submitted at the time of supply order and additional 5% at the time of completion of warranty & shall be released after fulfilling of comprehensive maintenance. No proportionate refund of the security money will be allowed if the supplied quantity falls below the ordered quantity.

3. TECHNICAL BID:

3.1:- Application:-

Bidder will have to upload the prescribed application format (Annexure -1) duly filled in and signed indicating full communicating address with Pincode, Telephone No, Fax and others.

3.3:- Turnover Criteria:-

The minimum average annual turnover of Original manufacturer for financial year 2020-2021,2021-22,2022-23, should be Rs30.50 lakhs. The certificate to the effect with the **UDIN** issued by practicing Chartered Accountant should be uploaded (Annexure 2) along with the copy of balance sheet duly attested by chartered accountant for the financial year2020-21,2021-22,2022-23. The turnover should be in terms **of Bailing machine exclusively**.

3.4:- Tender Fee:-

Copy of demand draft on account of tender fee should be uploaded. The original demand draft(Hard copy of DD) should be submitted at the Directorate of Sheep husbandry Kashmir by the last date of submission of Technical Bids Online.

Valid exemptions certificate for exemption of tender fee issued under price preference rules for MSME's should be uploaded.

3.5:- PAN CARD/IT RETURNS:-

PAN Card of bidder (In case of authorised distributor ,pan card of both distributor & manufacturer) issued by the competent authority should be scanned and uploaded.Bidder has to upload Copy of IT return for assessment year 2020-21,2021-22,2022-23. Authorised distributor has to furnish his IT returns as well as IT returns of the principal manufacturer.

3.6:- **GST REGISTRATION:**-

Each bidder will have to upload original GST registration & latest return file copy if applicable. Authorised distributor has to furnish his GST registration as well as GST registration of original manufacturer.

3.7:- There should be no vigilance or CBI Case pending against the Principal manufacturer, a self-attested certificate to this effect of Principal manufacturer is to be uploaded. In case of Authorised distributor a self-attested certificate to this effect of Authorised distributor as well as Principal manufacturer have to be uploaded.

Note :All manufacturers /companies of national repute are eligible for participation in the tenders. The companies can also participate through their authorised distributor, however for eligibility ,terms and conditions shall be fulfilled by principal/original manufacturer. Companies participating through authorised distributor shall have toupload a letter of authority in favour of the distributor as per Annexure-4.

- a. The bidder(manufacturer or Principal of authorised representative) has to submit Performance statement of last three years as per Annexure 3 as part of technical bid.
- b. The bidder (manufacturer or Principal of authorised representative) should have manufactured and supplied cumulative of at least six numbers of the product the last three years ending on the date of issue of tender(Supply orders to be attached) as part of technical bid.

4. FINANCIAL BID:-

- 4.1:- The financial bid shall be made online only on the website www.jktenders.gov.inDisclosure of rates/discounts/special offers in the technical bid may be understood as malpractice and such bid may be rejected.
- 4.2:- The offered rates in the bill of quantities should be quoted for one unit (i.e.one piece.)
- 4.3:- Financial bids of only technically qualified bidders shall be opened.

5. RATE:-

5.1:- The rates offered in the tender shall under no circumstances exceed the lowest price at which the supplier has supplied items of identical description to any other Govt. / organization or person anywhere in the open market during the period of rate contract in the UT. If incident of quoting higher rate to this department comes to the notice at any point of time during the course of rate contract period undersigned reserves the right to initiate an appropriate action

- against such firms including Blacklisting, Recovery of excess amount paid as well as forfeiture of performance security.
- 5.2:- Rates shall be inclusive of all taxes (However Gst shall be shown separately) and all incidental charges like unloading, weighing, storing, carriage(F.O.R) for decentralised units of Sheep husbandry department as decided by the department.
- 5.5:- The rate is/are to be quoted in INR or Paisa in net decimal coinage only.
- 5.6: Enhancement of rate under no circumstance will be accepted whatever the reasons thereof.
- 5.7:- Abnormally low rate of any supply quoted by the bidder in the offer without sufficient reason if detected will not be accepted. The Chairman DLPC reserves the right to reject any or all tenders at any stage without assigning any reason thereof.
- 5.9:- The successful Tenderer shall have to complete the supply within the stipulated period of time as set in the supply order. Failure to execute the supply would be considered the violation of the terms and conditions of NIT and liable to penalty as per tender conditions.

6. PERIOD OF RATE CONTRACT:-

6.1:- The Rate contract shall remain valid for a period of 1 year from the date of issuance or till the new rate contract is issued whichever is earlier.

6A - Comprehensive Maintenance.

- 6A.1 The warranty shall be for two years followed by comprehensive maintenance for a period of five years. The comprehensive maintenance shall start after the expiry of warranty period.
- 6A.2 The manufacturer/principal bidder has to extend warranty obligations for a period of two Years from the date of installation, for which 5% of supply order value as performance security in the form of FDR/CDR shall be furnished. Further the manufacturer/ principal bidder has to undertake comprehensive maintenance for a period of 05 years post warranty period for which the manufacturer/principal bidder has to submit 5% additional security in form of extendable bank guarantee at least valid for 05 years of comprehensive maintenance period at the time of start of maintenance period and that shall be released after completion of comprehensive maintenance.
- 6A.3 During warranty period supplier has to replace/repair defective (bailing machine/parts) and provide free service (including visiting, charges of the consumables lubricants, oil etc.) without any charges.
- 6A.4During the period of comprehensive maintenance the machine is to be maintained free of cost by the supplier.No maintenance charges including visiting charges and charges of the spares, consumables lubricants, oil etc shall be paid.

7. AGREEMENT:-

7.1:- The successful bidder will have to enter into a contractual agreement with the Directorate of Sheep Husbandry Jammu/Kashmir as the case may be within 10 days after award of the contract on the non-judicial stamp paper worth Rs20/= at their own cost. In the event of

failure to execute the agreement in the prescribed manner within the stipulated period by the successful bidder shall forgo the right of the bidder to participate in future tenders of the directorate.

- 7.2:- The agreement should be typed only on one side of the stamp paper duly signed by authorized signatory on each page. The continued pages should be typed on the conquest paper.
- 7.3:- The parties to the contract are the firm and the department of Sheep Husbandry J & K duly represented by the Director Kashmir as the case may be.
- 7.4:- There shall be no binding on the department to issue supply orders for all and any item of approved supply by DLPC irrespective of approved contract. The authority does not guarantee purchase of all the quantity since procurement depends upon the actual requirement evaluated by the field units; hence the rates should be quoted accordingly.

8. PAYMENT:-

- 8.1:- The tax invoice against all supplies will be sent in triplicate to the intending officer. In case the item is imported a copy of bill of entry should be attached with invoice. The payment shall be made after satisfactory completion of the supply order. No advance payment shall be made under any circumstances.
- 8.2:- Payment shall be made after satisfactory completion of the contract in all respects however no interest shall be paid to the successful bidder in the event of delay in making payment due to whatsoever reasons. In no circumstances supply schedule should be affected or linked with the payment of outstanding bills. The payment of bills will be withheld in case of violations.
- 8.3:- All due payments shall be made after deductions of applicable TDS.
- 8.4:- It shall be obligatory upon every successful bidder to certify on each and every bill that quoted rates are reasonable and are same as are being charged to other government or any other semi government institutes.

9. PENAL ACTION:-

- 9.1:- If the bidder refuses to enter into written agreement for any or all supply within the time specified when requested to do so by the department or refuse to deposit the security money, such contracts offer will not be taken into consideration and shall be liable to be blacklisted for next 3 years from the date of reporting.
- 9.2:- The deposited security money furnished by contractor is liable to be forfeited in full by order generating authority and order amount will be cancelled without prejudice, in the event of failure/refusal to undertake the supplyas per the schedule, on the recommendations by the order generating authority Chairman DLPC will be at liberty to terminate the contract as whole or a part.
- 9.3:- The quoted rate shall not exceed the price at which bidder has executed the supply of same description to any other government directorate, organization, private institution etc during the period of rate contract, if such instances of higher rates comes to notice, the authority deserves the right to cancel and blacklist the contractor.
- 9.4:- Non-compliance of terms and Conditions laid herein shall constitute the breach of contract andNon-compliance shall be enforced very rigidly.

10. MISCELLANEOUS:-

- 10.1:- The successful Tenderer shall not assign or sublet the contract in part or in full to any other agency. In all such cases the contract shall be cancelled.
- 10.2:- Any condition that is not indicated in the NIT can be incorporated in the supply order before the agreement for execution of the contract, if needed.
- 10.3:- GFR, Manual for procurement of goods and services and any other latest guidelines issued by the government pertaining to purchase of stores and services, shall be followed, even if, there is no specific instruction in this tender document.
- 10.4:- All the issues that may come up during the completion of contract shall be decided by DLPC J& K and the decision of the Chairman DLPC Sheep Husbandry Department J&K and the decision shall be final and binding upon the firm.
- 10.4.1:- Any dispute arising out of or in connection with this contract, including any question regarding its existence ,validity and termination ,shall be referred to and finally resolved by arbitration in accordance with the Jammu and Kashmir International Arbitration centre(Arbitration proceedings)Rules.
- 10.5:- That in case of any dispute Principal secretary, Sheep Husbandry Department; Kashmir shall bethe arbitrator and his decision shall be final and binding on the parties.
- 10.6:- The seat of arbitration shall be Srinagar.
- 10.7:- The language of the arbitration shall be English.
- 10.8:- The laws governing arbitration shall be the laws of India.
- 10.9:- When a tendering firm submits there tender in response to this notification they will be deemed to have understood fully, contents, requirement, terms and conditions of tender. No extra payment will be made on the pretext that tendering firm did not have any clear ideas of a particular point. Any offer made in the response of this tender when accepted by tendering authority will constitute a contract between the parties.
- 10.10:- All notices intended to be served to the bidder will be deemed to have been duly served, if sent by the registered post to address mentioned in the tender or any other address permissible by law. All the instructions given in the tender notice, forms are binding upon the bidder. In the event of delay/non-availability, garbled printout, inaccessible website for downloading tender documents, the tender signing authority shall not be held responsible. Everydocumentuploaded should be clearlyvisible otherwise it will not be considered.
- 10.11:- Force majeure clause shall not be acceptable.
